As a proud member of the Technical Community Coalition for Multistakeholderism (TCCM), KeNIC celebrates the adoption of the Global Digital Compact (GDC) by consensus. This crucial step brings us closer to building a more inclusive, open, secure, and sustainable digital future for everyone.

The Internet remains the core infrastructure enabling digital technology, and the GDC acknowledges the importance of keeping it open, global, interoperable, and secure for all. KeNIC, alongside fellow TCCM signatories: Africa Top Level Domains Organization (AFTLD), Asia Pacific Network Information Centre Administration (auDA). (APNIC). .au Domain Blacknight, Canadian Internet Registration Authority (CIRA), DENIC eG, DNS Africa Ltd, DotAsia Organisation, GoDaddy , IE Domain Registry CLG (trading as .ie), InternetNZ (.nz), Japan Network Information Center (JPNIC), Japan Registry Services Co., Ltd. July 17th 2024: In collaboration with the Office of the Data Protection Commissioner (ODPC), we were pleased to host a Data Protection Training for our registrars at The African Advanced Level Telecommunications Institute (AFRALTI). This training was held for 4 days, from 15th to 18th, 2024.

The training was designed to equip our registrars with essential knowledge for handling sensitive and personal data responsibly, ensuring compliance with the 2019 Data Protection Act. This initiative underscored our commitment to securing registrant information and upholding data protection standards.

3. KeNIC Hosts African ccTLD Registries

July 19th 2024: KeNIC welcomed representatives from nine ccTLD registries for a one-day learning visit, including Angola (.ao), Benin (.bj), Burundi (.bi), Comoros (.km), The Gambia (.gm), Madagascar (.mg), Niger (.ne), Togo (.tg), and Zimbabwe (.zw).

The visit aimed to accelerate growth, exchange valuable knowledge, and empower all participants within the DNS ecosystem to contribute to local and regional digital transformation.

The workshop is part of the broader Coalition for Digital Africa (CDA) Country Code Top-Level Domain (ccTLD) capacity development program, which aims to enhance the ability of African ccTLDs to better manage their registries and further contribute to the growth of their local digital economies.

Andrew Mwanyota Lewela, KeNIC Chief Evangelist & CEO, expressed his enthusiasm for the partnership: "This collaboration aligns with our vision of maximizing the value of the internet for all Kenyans. By working together, we can create a more inclusive and digitally empowered society."



The MOU is initially signed for a three-year period and will focus on key areas such as:

- Digital governance: Addressing issues related to online governance and cybersecurity.
- Digital skills development: Providing training and resources to enhance digital literacy.
- Public awareness: Increasing visibility and understanding of the .KE domain and its benefits
